Dear Board/Commission Applicant:

The nomination period for applications may open prior to the seat being vacated. Please return your application to the City Clerk's Office, 600 East A Street, Dixon. Be sure to submit your application in advance of the published final filing date. Note: Email and Fax applications will not be accepted.

The process for selecting a Boardmember/Commissioner is: the Mayor will interview applicants approximately two weeks after the application period closes. The Mayor may ask a Councilmember and/or City staff department head (e.g. the Community Development Director for the Planning Commission applicants) to attend the interviews.

After the Mayor makes the decision, approximately one week after the interviews, the City Council will be advised of the decision. The Mayor will announce the recommendation at a Council meeting at least two weeks in advance of the meeting at which the appointment will be voted on by the full Council.

Usually, the City Council appointment vote will be held at the next City Council meeting after the Mayor's initial announcement. The City Council vote confirms the appointment.

If you are selected by the Mayor, you will be so advised prior to the Mayor's announcement. After the City Council confirmation vote, you will be sent a letter confirming your appointment to the board/commission. Included with your confirmation letter will be board/commission orientation and personnel processing information. Also, you may be contacted by the press.

Also Boardmembers/Commissioners are required to file Statements of Economic Interests annually as required by the Political Reform Act disclosing personal information including investments, interests in real property, income, etc.
